1. Complete 40 hours of anger management facilitator training with emphasis in each of the following areas: (1) Adult, parent, child anger management; (2) child development, from birth through adolescence (3) family and domestic violence; (4) family conflict and anxiety; and (5) stress management child abuse;
2. Use a reliable assessment tool that includes a **Pre-** and **Post-**Test to measure outcomes; AND
3. Receive 16 hours of continuing education annually in any of the above areas.

Any provider offering anger management for clients referred from Family Court must address at least the following core topics during the anger management program:

- Gaining personal control
- Stress Management
- Basic Communication Skills
- Role Modeling and Positive Parenting Reinforcement
- Child Abuse and Corporal Punishment
- Coping with Stress
- Triggers, Provocation and Alternative Responses
- Identifying Distorted Thinking
- Irrational Beliefs
- Identifying and Expressing Needs
- Assertiveness vs. Bullying
