If convicted of this offense, the court may order you to be placed in an education and counseling program. (Education Code § 48293.)

If you believe the judicial officer assigned to hear your case is prejudiced against you, you may make a motion to disqualify that judicial officer pursuant to section 170.6 of the Code of Civil Procedure and the case will be re-assigned to another judicial officer. (Welf. & Inst. Code § 700.2.)
